Recent publications from NHS Fife staff: October 2021

This monthly bulletin aims to raise awareness of research activity across NHS Fife.

Core medical/health databases were searched to identify articles where at least one author is a member of staff from NHS Fife. Research activity may have been carried out solely by NHSF staff or in collaboration with colleagues from external institutions.

Databases searched: Medline, Embase, PsycInfo, Cinahl.

We searched for records added to the databases during October 2021.

We included: articles, conference abstracts, letters.

Where practicable we excluded: errata, corrections, comments, author's responses.

Local authors are highlighted in yellow so they can be readily identified.

If you're trying to access full-text from a device not connected to the network, you may need to login with your NHS OpenAthens username and password.
